And if further appearing to the Commission and the Commission finding as a fact, that the closing of the portion of Harold Street, as described in the Petition filed in this cause, is not contrary to the public interest or the property rights of any individual, and that no individual owning property in the vicinity of said portion of Harold Street or in the subdivision in which such street is located will be deprived of reasonable means of ingress and egress to his property by the closing of said portion of Harold Street, and it further appearing to this Commission that the relief prayed in the Petition should be granted.

IT IS NOW, THEREFORE, ORDERED AND DECREED by the County Commission of the County of Rowan, North Carolina, pursuant to and in accordance with the Authority vested in this Commission by the General Statutes of North Carolina, Section 153A-241 that such Petition is hereby GRANTED.
